### Student Feedback on Curriculum for the academic year 2022-23

**Background:** During the Academic year 2022-23, Feedback was taken from students on different aspect of their academic experience at the University

### 2. Curriculum Coverage:

Respondents were asked about curriculum Coverage. The feedback from 854 students indicates a high level of satisfaction with the curriculum coverage, as 93.79% rate it as good.

This strong positive response confirms the effectiveness of our current curriculum design. However, to continuously improve and address any underlying concerns from the remaining respondents, we will further analyze specific feedback and explore areas for enhancement

### 3. Depth of Course content:

Respondents were asked about depth of Course content

The survey results show a strong positive response regarding the depth of course content, with 91.8% of the 854 respondents rating it as Good or Very Good. This high level of satisfaction validates the quality and thoroughness of our curriculum. To continue our commitment to excellence, we will maintain the current standards while also seeking ways to further enhance the depth and breadth of our course offerings.

### 4. Applicability / relevance of curriculum in life situations

Respondents were asked about applicability / relevance of curriculum in life situation

The survey results from 854 students show a strong affirmation of the curriculum's relevance, with 92.97% recognizing its applicability to real-world contexts.

This high level of positive feedback supports the effectiveness of our current educational strategies. To ensure continued relevance and applicability, we will sustain our efforts in regularly updating and aligning the curriculum with industry trends and professional standards.

### 5. Learning Values (in terms of Attitude, Ethics, Broadening perspectives)

According to the information provided, 92.16% of the 854 students believe that the subject plays a significant role in fostering values such as attitude, ethics, and broadening perspectives. To build upon this success, we will continue to prioritize the integration of values-based education across our programs and seek opportunities to enhance students' holistic development further.

Among the 854 surveyed students, 91% expressed confidence in the quality of their learning skills, spanning research, teamwork, leadership, and communication. This positive feedback underscores the effectiveness of our educational programs in nurturing essential competencies.

To sustain and enhance these outcomes, we will continue to provide opportunities for skill development and offer support services to further refine students' capabilities in these areas.

### 7. Adequacy of available practical facilities in terms of curriculum

The feedback indicates that 90.51% of respondents are satisfied with the practical facilities, viewing them as very good or good and suitable for meeting the curriculum's needs. This high level of satisfaction validates the adequacy of our facilities in supporting educational outcomes. However, the 0.59% dissatisfaction rate, although minimal, will not be overlooked. We will conduct a detailed evaluation to identify specific areas of concern within these facilities and implement necessary improvements to ensure that all aspects of our practical facilities fully meet the needs and expectations of our students

## 8. Relevance and adequacy of available Library books and resource material in terms of curriculum

The survey results demonstrate strong satisfaction with our library resources. This positive feedback confirms that our library collections are effectively supporting the curriculum and the academic needs of our students.

4. The system followed by the University for the design and development of the curriculum is effective

The survey results reveal that a substantial majority of respondents, with 86.08% strongly agreeing and 13.92% agreeing, find the university's curriculum design and development system to be effective. This strong endorsement underscores the success of our current methodologies. To ensure continuous improvement and responsiveness to feedback, we will maintain ongoing evaluations and incorporate innovative practices as needed.

Despite the positive feedback, the 6.33% of respondents who are neutral or disagree highlight an opportunity for further enhancement. We will conduct targeted follow-up surveys and focus groups with these respondents to understand their concerns and identify any specific areas needing improvement.

The data highlights strong support for the involvement of external experts in Postgraduate Boards of Studies, with 92.4% of respondents acknowledging its value in course design and enhancement. This affirmation, comprising 59.49% strongly agreeing and 32.91% agreeing, underscores the importance of external input in improving course quality.

However, the 7.59% of respondents who are neutral or disagree provide an opportunity for further exploration. We will engage with this group to understand their perspectives and gather insights for potential improvements

### 7. The designed curriculum meets the needs of the student.

Respondents were asked about designed curriculum meets the needs of the student.

The survey results indicate overwhelming consensus, with 98.64% of respondents affirming that the curriculum effectively meets student needs. This strong positive feedback validates our curriculum design and implementation strategies.

To continue ensuring our curriculum's relevance and effectiveness, we will maintain ongoing engagement with both students and faculty to capture any shifts in educational requirements or student expectations

### 8. The curriculum addresses the cognitive domain to the desired level.

However, the 1.27% of respondents who remain neutral highlight a potential area for further inquiry and improvement. To address this, we will undertake a more detailed analysis to identify any specific concerns or gaps perceived by these respondents

## 10. The curriculum addresses the skill/psychomotor domain through practical/clinical-based training.

The feedback indicates a robust approval of our curriculum's practical and clinical-based training in the skill/psychomotor domain, with 98.74% of respondents strongly agreeing or agreeing. Despite this strong positive response, the small percentage (1.27%) of neutral feedback prompts further investigation. We will engage with students during and after such training to identify potential improvements to our practical training components. This will ensure that our programs continue to meet and exceed the needs of all students, maintaining our commitment to providing high-quality, comprehensive education.

### **Employers Feedback**

### 1. Demonstrates sound Scientific Knowledge

Responded were asked about whether graduates demonstrates sound Scientific knowledge

Following the assessment, we've noted the positive feedback regarding the demonstration of sound scientific knowledge, with 89.36% of respondents rating it as good. However, we acknowledge the 4.26% who indicated need of improvement performance.

To address this, we conducted a review of teaching methodologies, and determined that emphasis on newer methods of teaching would be continued.

### 2. Demonstrates Skills In patient care effectively

Respondents were asked about Demonstrates Skills In patient care effectively

Based on the feedback from employers, the satisfaction levels regarding the patient care skills demonstrated by our graduates are commendably high.

In response, we will continue to uphold and refine our training programs to maintain and enhance the quality of education. Specific focus will be given to ensure continuous improvement and excellence in all aspects of patient care training for potential or slow learners.

#### 3. Communication Skill

Responded were asked about their Communication Skills

Based on the feedback received, 87.24% of respondents rated their communication skills positively, with a majority considering them good or excellent and 4.26% suggesting they need enhancement.

As an immediate action, we will review and refine our communication skills teaching to provide more confidence building measures. Additionally, we will enhance ongoing monitoring and support mechanisms to ensure continuous development and to achieve higher overall effectiveness in communication skills across all students.

### 4. Professional Grooming:

Responded were asked about Professional Grooming

Based on the feedback received, it's evident that a significant portion of respondents are satisfied with the grooming session, with 68.09% rating it as good and 12.7% as very good. However, 4.2% deemed it unsatisfactory.

To address this, we will ensure feedback of each session is taken informally to fill any knowledge gaps. Additionally, we will continuously monitor and address concerns, ensuring a consistently high standard of service delivery.

### 5. Use of Technology

Responded were asked about Use of Technology by our graduates

Based on the survey results, which show that 85.11% of respondents rate their technology use as good to excellent, we can conclude that the majority of our community is proficient with technology. However, 2.13% see room for improvement.

As an immediate step, we will initiate targeted training sessions to boost the competencies of those who rated their skills as average or needing improvement.

## 6. Rating of overall satisfaction with a competency of our candidate

The survey results indicate strong satisfaction with the candidate's competency, with 89.37% of respondents rating it as "Good" or "Very Good." This demonstrates effective alignment with our educational objectives and the skills we aim to instill in our candidates. However, a small percentage of 4.26% rated the competency as "Unsatisfactory."

To address this feedback, we will review the specific areas where improvements are suggested and implement targeted enhancements in our training programs. We will also provide additional support and resources to ensure all candidates can meet and exceed the required competency standards in future assessments.

## 7. Whether you feel all necessary competencies/learning objectives are included in the current curriculum?

The survey results demonstrate robust faculty involvement in curriculum-related activities, with a high approval rating of 91.6% from respondents who agree or strongly agree with the level of faculty participation. While the positive response is encouraging, the presence of 8.94% neutral responses suggests there is room to enhance faculty involvement further. Actions will include targeted faculty development programs and opportunities for increased participation in curriculum planning and assessment. ### 1. Nature of your experience with the institution

Majority of feedback was from Examiners for the different programs. It is determined to expand the professional feedbacks to parents who are from relevant professions.

As a response, we will continue to uphold the high standards of our curriculum while also initiating a focused review to understand the specific aspects that may lead to neutrality among some respondents.

### 5. The curriculum addresses the cognitive domain to desired level

Responded were asked about thus the curriculum addresses the cognitive domain to desired levelThe survey results demonstrate strong support for our curriculum's effectiveness in addressing the cognitive domain, with 97.33% of respondents. The positive response is encouraging and validates our current educational strategies. We will continue monitoring feedback and outcomes to maintain the high standards.

## 6. The curriculum addresses skill/psychomotor domain through field/ practical/ clinical/ project-based training

To address this, we will further investigate the reasons behind the neutrality through follow-up surveys or discussions to pinpoint any gaps or areas for enhancement.

# 7. The curriculum provides training to students in the soft skilled-communication, professionalism, ethics

The survey results affirm the effectiveness of our curriculum in emphasizing essential skills like communication, professionalism, and ethics, with a strong agreement from 90.66% of respondents. However, the 9.34% who remained neutral or uncertain warrant attention as to need for revision or repeat classes for those who remain absent.

## 8. The curriculum provides training beyond the minimum prescribed curriculum

4% students were uncertain about the additional beyond-prescribed curriculum training being given.

Efforts to familiarize students with the minimum curriculum will be made at time of orientation and revision classes.

## 9. Faculty are participatory in the development, revision, and delivery of the curriculum.

Responded were asked about Faculty are participatory in the development, revision, and delivery of the curriculum.

The significant engagement of 96.1% of faculty members in shaping the curriculum reflects a strong commitment to collaboration and continuous improvement. However, the 4.00% who remain neutral warrant further exploration.

We'll reach out to understand their perspectives better and ensure all faculty members are actively involved in curriculum development. This ongoing collaboration will help us maintain and enhance the quality and relevance of our educational programs
