- Candidate attending counseling should satisfy the eligibility requirements as per the NEET Information Brochure-2022 and the minimum eligibility requirements as prescribed by the NMC/MCI Regulations for admission to MBBS Course.
- The physical presence of the candidate is mandatory; no third person will be allowed to enter the counselling hall.
- Candidate Selected for Management/Paid Quota seat is required to pay the prescribed fees in the form of RTGS/NEFT etc., candidate shall make all prior arrangements for the same and he shall bring the updated bank passbook/bank statement which is showing the sufficient balance in their account.
- Candidate Selected for NRI Quota seat is required to pay the prescribed fee from NRI account of the Sponsor.
- In case the seats under NRI quota fall vacant, then the same will be converted into Management/Paid category and counselling for such seats will continue/conducted on inter-se-merit at given time.
- No cancellation will be entertained after allotment/admission.
